TABLEHOLDERS AND EXHIBITORS AGREEMENT FOR THE 42nd ANNUAL W.S.S.C.A. SPORTS COLLECTORS CONVENTION AT MERIDIAN PARK SCHOOL IN SHORELINE, WA

Saturday and Sunday, May 31st and June 1st, 2014 Show Hours: Saturday 9:00 AM to 5:00 PM; Sunday 9:00 AM TO 3:00 PM Set-Up: Friday 6:30 to 9:00 PM; Saturday 7:00 to 9:00 AM; Sunday 8:00 to 9:00 AM

By signing this Agreement, Tableholder (also referred to herein as "Dealer") understands, acknowledges, and agrees to conform to all terms and conditions described herein.

- A. Gambling devices and games of chance are prohibited. No exceptions.
- B. <u>Grab bags conditionally allowed</u>. Content/count must be accurately described; not allowed are grab bags advertising a chance at a premium value card(s) on a random basis over and above the price of an individual grab bag. We cannot regulate odds/veracity; this form of gambling is not allowed.
- C. No beanies allowed, and no POGS allowed. No exceptions.
- D. No comic books allowed. Exceptions made for comics with sports-related themes.
- E. Non-sport cards. Non-sport cards have long been a part of sports collecting shows. Allowed non-sport cards: pre-1980 movie, TV, music, animal, geography, national themed, coca-cola, pop icons, and other benign themes. Non-allowed non-sport cards: pokemon, magic, or related merchandise, as well as, but not limited to all full/partial nudity sets (Thee Dolls, Playboy, Hustler etc.), all swimsuit sets, weird themes (tattoo art, injury to eye etc.), cheesecake/pin-up art sets, Bettie Page, Fantasy Art sets (Frazetta, Boris, Olivia), graphic violence, Serial Killer, etc. Any tableholder found selling non-allowed non-sport cards shall be asked to remove them immediately. Tableholder understands and agrees that failure to do so may result in a loss of table rights, including immediate forfeiture of table.
- F. Reprints, counterfeits, and "doctored" cards. Reprint cards available for sale must clearly be marked as "reprint." The sale of counterfeit or "doctored" cards at W.S.S.C.A. Conventions is absolutely prohibited. If you are uncertain whether or not a card is genuine, please contact a W.S.S.C.A. Officer before putting the card on your table for sale. Any Dealer caught knowingly selling counterfeit or "antiqued/aged" reprint cards will be persuaded to refund all monies to buyer(s), and will have his or her table closed without table fee refund or recourse of any kind. Similarly, any Dealer unknowingly selling counterfeit or "antiqued/aged" reprint cards will be persuaded to refund all monies to buyer(s); failure to do so will result in table closure without table fee refund or recourse of any kind. Dealer understands, acknowledges and agrees that WSSCA has sole and absolute discretion regarding this paragraph F.
- G. <u>Table content</u>. Any and all items relating to sports, sports collecting and related protection supplies are allowed. In addition, certain non-sport cards are allowed per paragraph E above.
- H. Name tags. Tableholders and their agents must wear W.S.S.C.A. name tags during set-up and during show hours. A limit of two dealers will be allowed for each table contract.
- I. <u>Set-Up and Break Down.</u> Dealers may begin set-up at 6:30 PM Friday and must be set up by 9:00 AM Saturday. All fees must be paid in full, and a signed contract completed, before Tableholder will be allowed to set-up or enter Convention site. No exceptions. All Dealers will remain set up until the Show closes on both Saturday and Sunday unless prior arrangements are made with the Convention VP. W.S.S.C.A. Conventions are

advertised as running until 5:00 pm on Saturday and 3:00 pm on Sunday. Early breakdown and/or departure, on either day, will result in disciplinary action up to and including forfeiture of table(s) for future Conventions. The Convention is closed to the public at 3 PM Sunday. Dealer understands, acknowledges, and agrees that break down should be fully completed by 4 PM Sunday as a means of allowing janitorial service to efficiently clean the facilities.

- J. <u>Tables</u>. Tables will measure eight (8) feet in length, and table covers and chairs will be provided. Dealer understands, acknowledges, and agrees that W.S.S.C.A. has sole discretion to determine Dealer table location. Dealer also understands, acknowledges, and agrees that no tables will be moved from the table layout set by the Convention VP without the approval of the Convention VP.
- K. <u>Insurance and liability</u>. Tableholder accepts full liability for any injury or loss to themselves, their family, their helpers, or their property during set-up, during show hours, and during break down after show hours have ended. Tableholder understands, acknowledges, and agrees to release W.S.S.C.A., its members, agents, and assigns from any and all liability, injury, or loss sustained during set-up, show hours, and break down after show hours have ended.
- L. <u>Taxes</u>. Tableholder understands agrees that tableholder is solely responsible for payment of taxes of all kinds, including but not limited to Washington state retail sales tax.
- M. Licensing. The city of Shoreline does not require a business or trade show license.
- N. <u>Convention cancellation by W.S.S.C.A.</u> If it becomes impossible or impractical to hold the Convention where and when anticipated, Tableholder understands and agrees this agreement will be cancelled without liability, and all table fees paid will be refunded to Tableholder. Tableholder understands, acknowledges and agrees that no special damages shall be awarded in event of cancellation by W.S.S.C.A. Tableholder understands, acknowledges, and agrees that in the event of cancellation by W.S.S.C.A. the sole remedy available to Tableholder will be a refund of table fees paid.
- O. <u>Cancellation by Tableholder</u>. Tableholder understands and agrees that a full refund will be given to a tableholder canceling no later than May 1, 2014, one-half of the table fee will be refunded to a tableholder canceling no later than May 24, 2014, and no refunds will be given to a tableholder canceling after May 24, 2014.
- P. <u>No subletting allowed</u>. Tableholder understands and agrees this Agreement shall not be transferred or sold to any other party.
- Q. <u>Table fees</u>. <u>Each table is \$90 if paid in full on or before March 15, 2014</u>. <u>All tables paid for on or after March 16, 2014 are \$125 each</u>. Please make all checks payable to W.S.S.C.A. and mail to W.S.S.C.A., P.O. Box 27040, Seattle, WA 98165.
- R. <u>Table availability and placement are not guaranteed</u>. Sign up early if you desire a table. Table assignments will start as early as March 15, 2014.
- S. No smoking. Smoking is not allowed on Meridian Park School grounds.
